2008 COLORADO EVAPORATIVE COOLING REBATE PROGRAM

ELIGIBLE CUSTOMERS

Xcel Energy residential electricity customers residing in Colorado are eligible for rebates when installing qualifying, energy-efficient evaporative cooling equipment.

Building contractors should negotiate with the homeowner to determine who receives the rebate.

ELIGIBLE EQUIPMENT

Equipment must be new and have a minimum Industry Standard Rated (ISR) airflow of 2,500 CFM. It must be a permanently installed direct, indirect or two-stage evaporative cooling unit.

Portable coolers or systems with vapor compression backup are not eligible, nor is used or reconditioned equipment.

A list of equipment that meets the minimum efficiency requirements for the program is available on our website at xcelenergy.com/Homecooling-CO, or by calling **1-800-895-4999**. Other equipment may be considered if acceptable documentation confirming the operational performance standards is submitted with the application.

Qualifying equipment is not eligible to participate in other Xcel Energy rebate programs.

REBATE DETAILS

Xcel Energy issues cash rebates in the form of checks, not energy bill credits. Rebates are valid only for equipment purchased between January 1, 2008 and December 31, 2008. Equipment must be purchased and installed prior to submitting the rebate application. Limit one rebate per household. Please allow at least six to eight weeks for rebate processing. **Rebate quantities are limited, and applications will be honored on a first-come, first-served basis.**

Our rebate program requires a completed application **and a copy of the dated sales receipt/invoice**. The application must include all information requested on the front of this form and must be postmarked no later than June 30, 2009. Incomplete applications will not be processed.

Xcel Energy is not responsible if your retailer provides you with inaccurate

information about the amount or conditions of the actual rebate. Xcel Energy will not rebate equipment that is mislabeled or misrepresented.

Xcel Energy reserves the right to conduct random inspections to verify installation of the evaporative cooler at the address indicated on the front of this application. If Xcel Energy inspects the appliance, the rebate application will not be processed until the inspection has been satisfactorily completed. Inspections may be performed after the rebate payment at Xcel Energy's discretion.

Xcel Energy is not responsible for any lost, late, stolen, ineligible, illegible, misdirected or postage-due mail. All completed submissions become the property of Xcel Energy and will not be returned.
